#### **ASSESSMENTS**

The taught modules are each assessed by a written coursework assignment (6,000 words each).

The Professional Practice Dissertation module will be assessed by submission of a dissertation (7,500 words). The Professional Practice Dissertation provides an opportunity for sustained, in-depth and intensive investigation into, and reflection upon, a specialist area of legal practice related to conflict resolution or intellectual property, depending on the award chosen. It is supported by an online study unit on research methods.
